Example profiles of potential candidates are:

Public Company CPA Executive

A CPA Executive who has been integral to a public company's success; has been part of the management team; has successfully implemented requirements of Sarbanes-Oxley Act; has served as the transformation agent; or has been part of creating the company's strategic plan.

Privately Held Company CPA Executive

A CPA Executive who has established, maintained or enhanced sound internal controls; has participated in creating and implementing the company's plan for growth and success; or is part of the company's management team.

Not-for-Profit

A CPA Executive (or equivalent) who has helped a not-for-profit establish and maintain a balanced budget; has successfully implemented the Nonprofit Integrity Act of 2004; has served as a transformation agent; or has been integral to the success and services of the organization.

Community Service

A CPA Executive who has participated in charitable, civic or religious activities that have had a significant influence on the community; spearheaded public service projects; or has served as a volunteer in local, state or national government.



Nominations are easy—simply complete the attached form and attach the nominee's curriculum vitae. **Nominations accepted from** employees, CEOs, outside accounting firms, outside legal firms and similar. Self-nominations are encouraged.

Those Eligible for nominations are for CPAs who are and senior financial executives from companies located in the East Bay and North Bay within the CalCPA East Bay Chapter boundaries.

Winner will be selected by an independent committee of financial executives and business leaders. **Winner will be announced** at the CPA Executive of the Year gala dinner Tuesday, January 22, 2007, at the Hilton Garden Inn, Emeryville.
