

The CalCPA Fresno Chapter looks forward to receiving your completed application. Scholarships are awarded based on the criteria below. Funds will be awarded at our annual Student Night in September.

**Eligibility:** Minimum qualifications:

- Student will be transferring to California State University, Fresno or Fresno Pacific University from one of the following schools:
  - State Center Community Colleges: Fresno City College, Reedley College, Madera Center, Clovis Center or Oakhurst Center
  - Porterville Community College
  - West Hills College
  - College of the Sequoias
  
- Student is required to show proof of acceptance to either school (CSUF or FPU) with the intent to pursue a bachelor's degree in business administration with an emphasis in accounting.
  
- Must have a 3.0 or above grade point average
  
- Must submit official copy of transcripts. The student must have completed Accounting 1A or its equivalent, and have completed 60 units.
  
- Must submit two letters of recommendation: at least one from a faculty member and one from an employer or local business person regarding the applicant's:
  - personal characteristics, such as honesty, integrity, leadership capabilities, motivation and ability to accept responsibilities;
  - intellectual ability and communication skills; and
  - desire to become a CPA.
  
- Must be a U.S. citizen or legal resident of the U.S. and submit a signed declaration attesting to eligibility.
